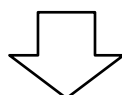


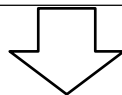
Submit an Expression of interest 提交感兴趣的意向

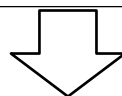
Check the Principal and/or Chief Instructor holds the appropriate RYA qualifications for each discipline. Check that you have suitably qualified instructors and equipment for the levels of recognition sought. Apply for recognition 申请认可

Submit an application for recognition. Forms required: Application for Recognition (AR1), Credit account application form, Recognition Payment Form (RPAY), Recognition Details form for each discipline for which you are seeking recognition. 提交申请以获得认证。所需表格：申请认可（AR1），信用账户申请表，认可支付表（RPAY），您正在寻求认可的每个课程科目的认证详情表。

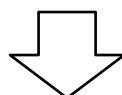
Once your application has been processed and verified you will be contacted by the RYA. Where necessary, an RYA Centre Inspector will contact you to arrange an inspection date (for practical, SRC and Sea Survival recognition). Distance Learning applicants will follow a staged application and review process. 一旦您的申请得到处理和验证，RYA 将与您联系。如有必要，RYA 中心检查员将与您联系以安排审查日期（实践基地，SRC 和海上生存认证）。远程学习申请的中心将遵循分阶段的申请和审核流程。



Inspection (if required) 审查（若需要）

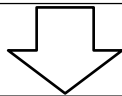
Prior to the inspection your Inspector will be able to offer advice if needed. 在检查之前，您的检查员将能够在需要时提供建议。

Shaded areas of form Centre Inspection Report form (IR1) should be completed by the Principal prior to the inspection. Your RYA Inspector will complete the rest of the form and an Action Plan which will detail any areas requiring attention. The Inspection Report and Action Plan will be sent to the RYA by the Inspector, with a copy of the Action Plan left with the centre. 中心检查报告表（IR1）的阴影区域应由主席在检查前完成。您的 RYA 审查员将完成表格的其余部分和行动计划，该计划将详细说明需要注意的任何领域。检查报告和行动计划将由审查员发送给 RYA，并将行动计划的副本留给中心。



Completion of action plan (if required) 完成行动计划（如果需要）

The Principal/Chief Instructor confirms when any action points have been completed. Subject to the nature of the action points, a second inspection may be required to verify compliance. 主席/主教练确认任何行动计划中的要点何时完成。根据行动计划中的要点的性质，可能需要进行第二次检查以验证合规性。



Confirmation of recognition 确认认证完成

Once RYA Training is satisfied with your application and/or inspection in all regards, recognition will be approved by RYA Training and a certificate of recognition will be issued. RYA training must not be advertised, sold or delivered until formal confirmation of RYA recognition has been received. 一旦 RYA 培训部对您的申请和/或所有方面的检查表示满意，认可将由RYA 培训部批准，并将颁发认证证书。在收到 RYA 认证的正式确认之前，不得广告，出售或交付 RYA 培训课程。
